Home Occupations, Signs and Zoning

Do you plan to operate a business out of your home? Sebastopol facilitates home businesses which do not disrupt residential neighborhoods. The City Planning Department can outline the parameters of "home occupation" regulations for you. Contact (707) 823-6167.

Is your business a permitted use in Sebastopol? Will it need a Use Permit or other special permits? Be sure to review applicable regulations and procedures before signing a lease or opening a business.

Do you want to install a sign for your business? The City has a local ordinance controlling the size, location and type of signs. Approvals are required before installing a sign.

Tenant Improvements/Construction

Do you plan on remodeling? Building permits are needed for most types of tenant improvements, such as electrical and plumbing changes, installation of new interior walls, or additions to buildings, as well as some types of sign installations. New buildings, additions, and some types of tenant improvements may also need Planning permits.

Encroachment Permits

Will you need to use public streets or sidewalks in your remodeling project? Use of the public sidewalks or streets for construction staging or other purposes requires an encroachment permit from the City. If the work involves use of a State Highway or right-of-way, separate approval from Caltrans is also necessary.

County/Regional Approvals

Are Sonoma County approvals needed for your business? For some types of businesses, approval from other agencies may be needed. Food sales require a Health Permit. Some commercial and industrial uses require a waste discharge permit from the City of Santa Rosa Environmental Compliance. A fictitious business name statement may need to be filed with the County Clerk.

State/Federal Requirements

Will you need State or Federal approvals or filings? For example, the State Department of Alcoholic Beverage Control issues licenses for sale of alcohol. The IRS will issue a Federal Employer Identification Number, the State Employment Development Department will issue a State Employer Identification Number. Sales or Use Tax may apply to your business; the State Board of Equalization issues permits. The Secretary of State accepts filings of articles of incorporation.
