

What do you think qualifies you to be appointed to this board/committee/commission?

As an architect, I understand the mandate of the Planning Commission and its role in decision-making as it relates to the General Plan, Zoning Code, growth and development issues. One of the roles of the Planning Commission is to enforce General Plan policies. As a member of the GPAC, I am intimately familiar with the General Plan update and am in position to understand the goals and policies as outlined in the General Plan. The General Plan will set the stage for revisions to the Zoning Code and other city ordinances and policies.

I have been engaged in planning related issues for some years in Sebastopol as a private citizen and as a member of the grassroots organization, The Core Project. I regularly read about current urban design and planning issues and consider their application to my community. I am a good listener and considerate of other people's opinions.

I live in Sebastopol and have a business located downtown. I am committed to working to build on Sebastopol's assets in creating a strong and resilient community.

Are there particular issues you think the board/committee/commission should concentrate on?

I think the Planning Commission should focus on creating a vibrant and safe environment for the community. I would like to bring some balance to planning decisions that have long prioritized the car at the expense of people. I think we are making progress, but have some way to go. I believe we need to improve the connections between our neighborhoods so that people feel safe leaving the car behind and walking and biking around town as much as possible.

I think we should focus development in our already developed areas and protect our urban growth boundary. There is a great deal of opportunity to develop at higher densities in town that will allow for a human scale while protecting our adjacent agricultural lands and natural ecosystems.

The Commission should be focused on policies and development proposals that support our existing businesses and allow them to thrive. Along with proposal that will allow the city and its residents to thrive as well. I am concerned that much of our development is 'low-value' and that we have an opportunity to increase the value of our community for long-term resiliency by crafting our zoning code and General Plan to encourage high-value development.

I would also like to focus on some of the planning ideas that were recommended through the SDAT process that I was part of several years ago. I think there were many great ideas recommended by the team that are not moving forward.

How should community comments be integrated into the board/committee/commission decision-making process?

I believe it is important to hear from members of the community that have opinions about issues before the planning commission either through written or oral communication. However, I believe that planning commissioners have a responsibility to rely on their own expertise and knowledge and that of city staff when making decisions. I don't think the planning commission should necessarily make decisions on issues facing the board based solely on public sentiment expressed to the commission. The people that show up to express opinions to the commission do not necessarily represent all of the community. In my experience as an architect, I see that project opponents are much more likely to speak out than project advocates.

If appointed, how would you handle it if another board/committee/commission member vehemently disagrees with your comments on a regular basis?

I would not expect all commission members to agree on all issues. I'm sure there will be disagreement. It may also follow that there may be consistent disagreement between members. It is a seven member board and decisions are made by a vote. I would try to explain my positions as clearly as possible in hopes of building agreement, but I would respect the decision of the majority even if I disagree.

How would you handle a situation where a proposal comes before your board/committee/commission that the City staff finds consistent with City policies and standards, but that you personally do not support?

I would make my disagreement clear in the public hearing and ask staff to clarify their position. If I still disagree with staff's position I would vote as I see appropriate on the issue at hand.

PLEASE ANSWER QUESTIONS BELOW AND SUBMIT WITH THE APPLICATION: What do you think qualifies you to be appointed to this board/committee/commission?

As noted above, my knowledge of the City's history, my skills as a researcher, and my experience with planning issues both as a private citizen and as a member of Sonoma County-wide Bicycle and Pedestrian Advisory Committee, Sebastopol Downtown Streetscape Committee, Sebastopol Complete Streets Advisory Committee, and GPAC.

Are there particular issues you think the board/committee/commission should concentrate on?

Although I feel the areas noted above are all important, I would call out in particular the issue of affordable and inclusionary housing. The price of housing in the City is increasingly making it difficult, if not impossible, for lower to middle income residents to remain. If we want to avoid becoming an enclave only for the wealthy and have a business community serving only the very well-heeled, we will likely need to make a number of important and thoughtful decisions over the coming years.

How should community comments be integrated into the board/committee/commission decision-making process?

Community comments should be considered, but not necessarily be the driver for decisions. Public comments are often a good way of expanding the scope of conversation, but may not represent the community at large; one of the important tasks of the Commission is to weigh those comments critically and come to well-considered decisions that may run contrary to public comments.

If appointed, how would you handle it if another board/committee/commission member vehemently disagrees with your comments on a regular basis?

I would first seek to privately come to an understanding of the dynamic with the other member and seek ways of working better with her or him; I would also seek the advice of the Chair or others on the Commission. As a new member, I would expect to work with at least one mentor who could help guide me. I would also critically review my own comments to judge how much weight to give the other member's vehemence, particularly if my comments were not alone in receiving such strong disagreement.



**STANDARD QUESTIONS:**

1. **What do you think qualifies you to be appointed to this commission?**  
I have served on both the Sebastopol Planning Commission and Design Review Board. My experience as an Architect has exposed me to a variety of land use issues in many jurisdictions throughout Sonoma County and the San Francisco Bay Area. I have enjoyed working collaboratively with my fellow Commissioners, and with the Planning Department Staff. I have four times attended the Annual Planning Commissioners Conference at Sonoma State, which has added to my understanding of planning and land use.

2. **Are there particular issues you think the commission should concentrate on?**  
Each application for proposed development should be reviewed for consistency with the intent of the General Plan. Where appropriate, the authority of discretionary approval should be used to ensure that the project will be of the highest possible quality.

Also, the Planning Commission will continue to work on the General Plan update, which is currently underway. This process, which I expect will be quite time consuming, is very important, as it will set the stage for the character and growth of Sebastopol over the next 20 years.

3. **How should community comments be integrated into the commission decision-making process?**  
Community comments are valuable to point out what may be varying interpretations of the General Plan. Also, these comments inform the Commission, as well as the applicant, of specific concerns. Often, a development proposal can be modified to eliminate or reduce concerns raised by members of the community.

4. **If appointed, how would you handle it if another commission member vehemently disagrees with your comments on a regular basis?**  
By its very nature, all members on a Commission will not always agree on every issue. Commissioners should present their positions clearly, with respect for differing positions that may be expressed by other Commissioners. Statements should generally be made to the Commission as a whole, rather than to another individual Commissioner. It is the responsibility of each Commissioner to conduct themselves in a way that is respectful to everyone else, including other Commissioners, staff, and members of the public. It is the responsibility of the Chair to ensure that the meeting runs smoothly, generally following the established rules of order.

5. **How would you handle a situation where a proposal comes before your commission that the City staff finds consistent with City policies and standards, but that you personally do not support?**  
If I agree with staff that a proposal is consistent with City policies and standards, I will support that proposal. However, if my interpretation of the intent of City policies and standards differs from that of staff, such that I do not agree with the staff recommendations, I will articulate my disagreement to my fellow Commissioners, encourage them to agree with my reasoning, and vote in support of my position.
