High-Efficiency Toilet Rebate Program Application

Application and Official Rules for the \$75 or \$150 one-time rebate

The City of Sebastopol offers a rebate for the installation of qualifying high-efficiency (HET) toilets in the form of a \$75 or \$150 credit on the water and sewer utility bill of City Residents. Residents should complete this application and submit to the Sebastopol Building Inspection Department located at 7425 Bodega Avenue. Once the application is received, the customer will need to make arrangements for a site inspection of the replacement HET toilet, by calling (707) 823-8597.

High-efficiency toilets can be purchased locally at Sebastopol Hardware Center 660 Gravenstein Highway North, or at other area home improvement stores.

QUALIFICATIONS:

- Not all high-efficiency toilets qualify for a rebate. ONLY models listed on the Sonoma County Water Agency website <http://www.scwa.ca.gov/sanitation-rebates/> qualify for the rebate. Rebate will be in the form of a credit on the customers City of Sebastopol water bill.
- Property owners are eligible for a one-time \$150 rebate with the replacement of a 3.5 or 7 gallon per flush toilet, or a \$75 rebate with the replacement of a 1.6 gallon per flush toilet to a 1.3 gallon or less, per flush toilet.
- Purchases must be made during the program's fiscal year from July 1 through June 30. Applications will be processed until funds are depleted, subject to funds availability. This program is subject to change or may end without prior notice. Offer Void where prohibited or restricted by law.
- Sales receipt must include purchaser name and installation address, purchase date, installation date, purchase price, brand and model number.
- The rebate will apply to each toilet that is replaced within the guidelines listed above.
- Please allow up to 12 weeks for your completed application to be processed. Incomplete applications will be returned.
