Fund 213, Traffic Impact Fund, was used for project costs.  
Pre bid project estimate was \$141,300; initial bid was \$117,689; extra work was \$15,575; contract total was \$133,264.

**INTRODUCTION:** This item is to request the City Council Accept the work performed for the Bodega Avenue/Ragle Road "RndRFB" Flashing Beacons and Median Project, and authorize staff to file a Notice of Completion.

**BACKGROUND:** The City Council previously awarded the contract for the Bodega Avenue/Ragle Road "RndRFB" Flashing Beacons and Median Project to the DC Electric Group, Inc. The contract price was \$117,689.00. The final project price was \$133,264.00 chiefly due to extra work to provide a new street light when moving an existing light proved impractical. The contractor has completed the work, and it has been inspected and approved by the City Engineer.

**RECOMMENDATION:** That the City Council adopt a Minute order for the Bodega Avenue/Ragle Road "RndRFB" Flashing Beacons and Median Project for the following:

1. Accepting improvements for public use;
2. Authorize staff to file a Notice of Completion
