

## NOTICE OF PUBLIC HEARING

Notice is hereby given that the City Council of the City of Sebastopol has scheduled a public hearing for the consideration and approval of the Sebastopol Solid Waste Collection Services Rate Adjustments by Recology Sonoma Marin pertaining to the implementation of State regulations "Senate Bill 1383" that requires minimum standards for organic waste collection services. The new monthly rates on the table below will be considered by the City Council and if approved, are proposed to be effective July 1, 2022.

If you challenge this rate adjustment in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the City of Sebastopol, at, or prior to, the public hearing.
